 - \$2,199,250 of ARP directly to eligible students in the Spring 2022 Semester
 - \$500 of ARP directly to eligible students in the Fall 2021 semester
 - Returned to ARP amount of (\$8,250) for voided checks from Summer 2021
 - Returned to CRRSAA amount of (\$11,103.08) for voided checks from Spring 2021

As of March 31, 2021, Southern Union State Community College had distributed ARP funds to 3,718 eligible students.

<u>Fall Semester 2021</u>: Southern Union determined how much a student receives based on their EFC with prioritizing students with greatest need. All eligible students enrolled in the Fall semester received the base amount of \$500. Those with an EFC range from 0 to 5846 based on the 2021/2022 FAFSA displays exceptional need and received additional award of \$250.

<u>Spring Semester 2022</u>: Southern Union determined how much a student receives based on their EFC with prioritizing students with greatest need. All eligible students enrolled in the Spring semester received the base amount of \$500. Those with an EFC range from 0 to 5846 based on the 2021/2022 FAFSA displays exceptional need and received additional award of \$250.
