CARES Act Higher Education Emergency Relief Fund (HEERF) II CRRSAA and III ARP -Student Portion

The information below is provided in compliance with the Department of Education's CARES Act Reporting requirements. The information in this report was compiled on September 30, 2021 and will be updated every quarter.

An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

Southern Union State Community College signed and returned the Higher Education Emergency Relief Fund (HEERF) Agreement to receive CARES Act funding on April 30, 2020. SUSCC has used no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Grants to students.

The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs:

Southern Union State Community College had distributed for quarter ending:

- September 30, 2021:
 - \$300.00 of ARP directly to eligible students in the Spring Semester
 - \$63,900.00 of ARP directly to eligible students in the Summer Semester,
 - \$2,364,000.00 of ARP directly to eligible students in the Fall Semester

The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

- Southern Union State Community College had approximately 4151 students eligible to receive Emergency Financial Aid Grants under the ARP program.

The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

As of September 30, 2021, Southern Union State Community College had distributed ARP funds to 4151 eligible students.

The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Summer Semester 2021: All students enrolled in the Summer semester received the base amount of \$300 of ARP grant funds. Students with an exceptional need that had 0 EFC on the 2020/2021 FAFSA received additional award of \$150.

Fall Semester 2021: Southern Union determined how much a student receives based on their EFC with prioritizing students with greatest need. All eligible students enrolled in the Fall semester received the base amount of \$500. Those with an EFC range from 0 to 5846 based on the 2021/2022 FAFSA displays exceptional need and received additional award of \$250.
