The Nursing Assisting Course may be offered in 5 or 15 week terms every semester on the Valley Campus and/or the Opelika Campus, depending on interest. The course is offered as non-collegiate credit (NNAS 9120 Certified Nursing Assistant) and as college credit (NAS 100 Long Term Care Nursing Assistant).

The Medication Assistant Course is offered in 10 week terms every semester on the Opelika Campus based on interest. The course is offered as non-collegiate credit only (NNAS 9102 Medication Assistant).

Eligibility Requirements:

1. Preferred high school diploma, GED, or current high school enrollment.
2. Receipt of application for CNA and/or Medication Aide program.
3. Medication Aide requires proof of CNA course completion.

Credit classes will require formal admission to the College.

Students must be aware that some employing agencies require employees to be age 18 years or older and have a high school diploma or GED prior to employment.

Clinical Requirements for admission to the program:

1. Current student malpractice insurance (added to initial costs)
2. *Annual Health Questionnaire* specific to the program of study verifying a state of physical and mental health such that the student is able to complete all program requirements without presenting undue risk/harm to the student or other persons.
3. Skin test for TB within the past year
4. Ability to meet *Essential Functions* requirements as specified in the program of study
5. Current immunizations, including proof of 2 MMRs, tetanus and Hepatitis B vaccinations (or waiver). The first Hepatitis vaccination is due prior to the first term of registration; the second Hepatitis B vaccination is due one month later; and the third Hepatitis B vaccination is due six months after the first vaccination.
6. Annual influenza (flu) vaccination (Spring and Fall semesters);
7. Verification of current CPR certification at the Health Care Provider level;
5. Negative Drug Screen (performed by school-approved vendor);
6. Criminal background check
7. COVID vaccination as required by the clinical agency
