Any student scoring at or above the established ACT or SAT score for either English/Writing or Reading within five years of enrollment is exempt from the subject specific placement assessment and is eligible for English 101.

## ENGLISH 101 and ENGLISH 102 Course Credit

Students who have an ACT score of 30-34 in English or a SAT Verbal score of 680-710 are exempt from English 101. Students who have an official ACT score in English of 35-36 or a SAT Verbal score $\geq 720$ will receive credit for English 101 and 102. ACT scores may not be more than five years old.
